**I. Course Description**

The primary focus of the course will be the completion of a full written report and presentation on the strengths and limitations of different strategies for addressing an environmental health issue. Completion of the project will require a professional level of analysis, documentation, and presentation (verbal, written, and graphical). Students in this course will demonstrate their ability to integrate the knowledge and skills gained from coursework and other learning experiences. To ensure a substantive grounding in the topics addressed in the project, the students will conduct a literature review of what is known about the issue, including different approaches for addressing the issue.

**II. Course Prerequisites**

Students in this course must have completed their bachelor's degree and be enrolled in the joint Bachelor's/Master of Public Health (4/1) degree program.

**III. Course Goals and Objectives**

By the end of this course, students will be able to do the following:

- Use research skills to learn about an environmental health issue in depth
- Investigate different strategies for approaching the issue
- Critically analyze data or literature to understand the strengths and weaknesses of different approaches
- Write a report on an environmental health issue for an educated audience
- Give a presentation on an environmental issue for an educated audience

#### **IV. Methods of Instruction and Work Expectations**

This course involves a combination of class discussions, one-on-one consultations with the instructor, student presentations, and extensive independent research that takes place outside of the classroom.

#### **V. Course Text and Readings**

Students will read primary literature and other sources they find as part of the process of their literature review.
