PROGRAM OVERVIEW

The Executive Master of Healthcare Administration (MHA) Program is ranked the #2 healthcare management program in the country by U.S. News and World Report and provides healthcare professionals with relevant, applicable knowledge for leadership in the healthcare industry. Built with the experience of the longest-running MHA program in the country, this accredited program is designed to fit the lives of busy professionals and is completed in less than two years.

The fully accessible online curriculum blends with a small number of synchronous sessions (in-person or online) to provide the foundation for learning from a diverse, cross-industry cohort. Graduates become part of the largest and most engaged alumni leadership network in healthcare.

ADMISSIONS

Admission to the program is decided by the executive MHA faculty with the advice and counsel of an admissions committee. Admission to the Executive MHA program requires the following:

APPLICATION REQUIREMENTS

- Official transcripts
- Resume or C.V.
- · Statement of purpose and objectives
- Three letters of recommendation

PREREQUISITES

- · Preferred undergraduate GPA of at least 3.0
- At least three years management or clinical leadership experience
- TOEFL score of 100 on the internet based (iBT) test for applicants whose native language is not English.

Each fall cohort consists of 30 to 35 students and includes diversity in profession, gender, ethnicity, age, geography and type of organization. Admissions are done on a rolling basis so we encourage prospective candidates to submit their applications as soon as possible.
