I. Course Description

This master's-level course focuses on quantitative skills and knowledge for interdisciplinary applications in genetics and molecular biology. Topics include gene association mapping, analyses of gene expression data from microarray experiments, analysis of next generation sequence data, false discovery rate estimation, gene set enrichment analysis and machine learning algorithms. Students will conduct extensive data analysis using R/Bioconductor.

II. Course Prerequisites

III. Course Goals and Objectives

By the end of the course, students should have a basic knowledge of statistical tools applied to human genetics, basic R/Bioconductor programming skills and substantial experience applying these skills and experience interpreting results and communicating these results to others.

IV. Methods of Instruction and Work Expectations

The course will use lectures and in class structured learning experiences to facilitate learning. Students will be evaluated based on their performance on homework exercises and a final project.
