#### I. Course Description

PubH 6386 is a graduate level course offered by the Division of Epidemiology & Community Health on the epidemiology and public health approaches to cardiovascular disease.

#### II. Course Prerequisites

Prior to enrolling in PubH 6386, students should have completed at least one course in epidemiology <u>and</u> one in biostatistics or statistics. If you do not meet these prerequisites, please see Dr. Folsom.

#### III. Course Goals and Objectives

The course will provide an introduction to cardiovascular disease (CVD) epidemiology. It is intended to provide a detailed perspective on the well-established risk factors for CVD, as well as an introduction to emerging risk factors. The course will cover some of the "classic" CVD epidemiology studies and clinical trials. The class will include a main focus on prevention of cardiovascular disease, and national recommendations for treatment and prevention. The class introduces students to the CVD research in the Division of Epidemiology. Several classes will cover new directions and current controversies in CVD.

#### IV. Methods of Instruction and Work Expectations

The course will include lectures, discussions, and homework. PDF versions of most slides used by Dr. Folsom are available on the course website. Class participation is required. Students will be evaluated as follows:

**Homework** is expected for most classes. Questions are on the website for downloading; to be answered and turned in <u>on paper</u> at the corresponding class or by <u>email</u> (to <u>folso001@umn.edu</u>) <u>before</u> class. Answers should be typed and concise. Late homework will receive a small grading penalty.

The **final** will be a take-home exam (to be arranged).

The main <u>text</u> is by Labarthe entitled "*Epidemiology and Prevention of Cardiovascular Disease*" from Jones & Bartlett, available at the Health Sciences Bookstore. <u>Articles</u> to be read are available for downloading via the course website.

#### VII. Evaluation and Grading

Both S-N and A-F grading are available. The University utilizes plus and minus grading on a 4.000 cumulative grade point scale in accordance with the following:

- B 3.000 Represents achievement that is significantly above the level necessary to meet course requirements

- D 1.000 Represents achievement that is worthy of credit even though it fails to meet fully the course requirements
- S Represents achievement that is satisfactory, which is equivalent to a C- or better.

F (or N) - Represents failure (or no credit) and signifies that the work was either (1) completed but at a level of achievement that is not worthy of credit or (2) was not completed and there was no agreement between the instructor and the student that the student would be awarded an I.

#### **Course Evaluation**

#### **Incomplete Contracts**

A grade of incomplete "I" shall be assigned at the discretion of the instructor when, due to extraordinary circumstances (e.g., documented illness or hospitalization, death in family, etc.), the student was prevented from completing the work of the course on time. The assignment of an "I" requires that a contract be initiated and completed by the student before the last official day of class, and signed by both the student and instructor. If an incomplete is deemed appropriate by the instructor, the student in consultation with the instructor, will specify the time and manner in which the student will complete course requirements. Extension for completion of the work will not exceed one year (or earlier if designated by the student's college).
